## **General Responsibilities:**

The **GMP Support Technician** will perform a variety of tasks in support of the daily production of sterile cell therapy product. Operations are predominately performed within a cleanroom environment under Current Good Manufacturing Practices (CGMP) conditions.

### Responsibilities:

- Perform daily room cleaning and disinfection duties in controlled and supporting areas
- Provides operational support for manufacturing activities including media/reagent preparation, kitting, cell freezing and equipment/materials staging
- Ensure adequate inventory of supplies and raw materials in the laboratory areas
- Perform cleaning, disinfection and chart change out of all equipment
- Follow batch records, SOP's and other cGMP documentation; complete all documentation in a clear and concise fashion.
- Assists during process activities and maintains clean room environment to comply with regulatory requirements.
